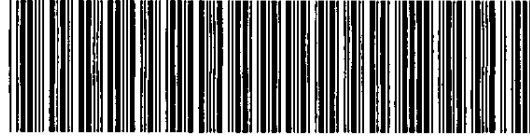



## **Amended and Added Articles of Incorporation**

**of**

### **Citilens Community Corporation**

#### **III**

##### **PURPOSE**

A. This corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

B. The specific purposes for which this corporation is organized include, but are not limited to:

1. Educating students and community members about employment and volunteer possibilities and opportunities in their communities;
2. Providing a means by which students and community members may discover potential mentors and key contacts within their industries or companies of interest;
3. Serving as a bridge between schools and the real world and closing the exposure gap impeding the success of certain children;
4. Mapping out the qualifications and skills for particular jobs so that students and community members have a better understanding of what they should do to improve their chances of employment; and
5. Encouraging students and community members to find their places in their communities.

#### **VIII**

##### **DECLARATION OF FEDERAL TAX EXEMPTION**

A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

C. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

## **IX**

### **PROCESS OF DISSOLUTION**

A. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

B. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
