Articles of Incorporation For

Article I Name

The name of the corporation shall be North Tampa Bay Senior Softball, Inc.

Article II Principle Office

Principle street and mailing address is 5555 Shasta Daisy Place, Land O Lakes, FL 34639.

Article III Purpose

North Tampa Bay Senior Softball, Inc. is a nonprofit Organization with the purpose of providing adults sixty (60) years of age and older the opportunity to play softball in a safe, fun filled, and respectful environment. Although there will be competition between teams, maintaining a safe and rewarding experience is paramount.

This corporation is organized and operated exclusively as a social and recreation club for the pleasure and recreation of its members and other nonprofit purposes within the meaning of §501(c)(7) of the Internal Revenue Code of 1986 (as amended) or the corresponding provision of any future United States internal revenue law. The social and recreational facilities of this corporation shall not be made available to the general public.

Article IV Manner of Election

The corporate board, known as the Board of Commissioners, will consist of five (5) elected officials, known as Commissioners, serving two year terms. Three (3) Commissioners will be elected in one year and two (2) Commissioners the following year. Commissioners will be elected by a majority vote of the league members attending an annual membership meeting held each April. Commissioners elected will assume office immediately after being elected.

Upon the dissolution or winding up of the Corporation, all of the business, properties, assets and income of the Corporation remaining after payment, or provision for payment, of all debts and liabilities of this Corporation, shall be distributed to a nonprofit fund, association, or corporation which is organized and operated exclusively for tax exempt purposes which are reasonably related to the purposed and goals of this Corporation, as may be determined by the Board of Commissioners of this Corporation in its sole discretion, and which has established its tax exempt status under §501(c)(7) of the Internal Revenue Code of 1986, as amended
