ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF

LEXINGTON CONCORD CONDOMINIUM ASSOCIATION, INC.

The undersigned, as an officer of LEXINGTON CONCORD CONDOMINIUM ASSOCIATION, INC., a Florida not-for-profit corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to the terms of Sections 617.1001 and 617.1002, Chapter 617, Florida Statutes, the Florida Not For Profit Corporation Act (the "Act"), states as follows:

1. The current name of the Corporation is LEXINGTON CONCORD CONDOMINIUM ASSOCIATION, INC.
2. The date of the filing of the original Articles of Incorporation of the Corporation with the Florida Department of State was September 9, 2015.
3. Article 2 of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety:

ARTICLE 2

PURPOSE

The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act, chapter 718 Florida Statutes, as it exists on the date hereof (the "Act") for the operation of that certain condominium located in Orange County, Florida, and known as LEXINGTON COURT, A CONDOMINIUM (the "Condominium") wherein the Association is designated as the "Association."

4. Except as modified by these Articles of Amendment, the Articles of Incorporation of Lexington Concord Condominium Association, Inc. shall remain the same and in full force and effect.
5. There are no members of the Corporation entitled to vote on this amendment. These Articles of Amendment to the Articles of Incorporation of Lexington Concord Condominium Association, Inc. were approved by of the Board of Directors of the Corporation.
