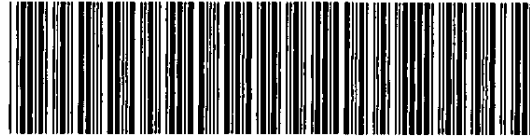

ARTICLES OF INCORPORATION
INTI RUNA PEOPLE OF THE SUN NATIVE AMERICAN CHURCH CORP
(A Florida nonprofit religious corporation)

Inti Runa People of the Sun Native American Church Corp, a Florida nonprofit corporation in Compliance with Chapter 617, F.S., (Not for Profit), adopts the following articles of incorporation for such corporation.

ARTICLE I NAME

The name of the corporation shall be: Inti Runa People Of the Sun Native American Church Corp.

ARTICLE II PRINCIPAL OFFICE

The principal street address for this corporation is: 105 NW 83rd Street, Miami FL 33150

ARTICLE III PURPOSE

This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious, spiritual, and educational purposes.

The specific purposes for which this corporation is organized is to cause and secure in principle and deed, the exercise and expression of aboriginal traditions and other indigenous American religious practices in accordance with the First Amendment of the United States Constitution, The American Indian Religious Freedom act (42 U.S. Code 1996), and the American Indian Religious Freedom Act Amendments of 1994 (Public Law 103-344), and in accordance with The American Indian Religious Freedom Act 21 U.S. Code 952, 953, and other pertinent laws; to carry out and perform religious and spiritual ceremonies that include but not exclusively limited to; the Name Giving Rite, Burials, Marriages, Spiritual Adoption, Ceremonies of Personal Health, The Sundance, The Moondance, Pow Wows, Community Gatherings, Ceremonial Dances, Sweat Lodges, Vision Quest, Coming of Age Ceremony, Pipe Ceremony, Staff Alliance Ceremony, All Night Prayer Vigils with but not limited to the use of Holy Sacramental Plants as specified in the Inti Runa People of The Sun Native American Church Corp. By-Laws and transport and use of Sacramental Plants, and other rituals, ceremonies and Sacraments of aboriginal peoples of the Americas with religious and cultural intent or passed via alliances with other organizations or churches. In accordance with spiritual aboriginal traditions and under the protection of The First Amendment of the United States Constitution, The American Indian Religious Freedom Act (42 U.S. Code 1996), The American Indian Religious Freedom Act Amendments of 1994 (Public Law 103-344) and in accordance with 21 U.S. Code 952, 953, and other pertinent laws; Inti Runa People of the Sun Native American Church Corp (Inti Runa NAC corp) and its rituals have, as a Holy Sacrament, Medicinal Plants and Herbs, as specified in the Inti Runa People of the Sun Native American Church Corp. by-laws.

Inti Runa People of the Sun Native American Church Corp's objective and purpose is to: Preserve, administer, uphold, safe keep, protect, share, educate, acknowledge, recognize, express, and honor; the cultural diversity of the original, native, indigenous, and aboriginal peoples of America through their ancient traditional religious and spiritual practices. Inti Runa People of the Sun Native American Church Corp is inclusive of the participation and/or representation of all the original Native American peoples throughout the North, Central, and South American Continent, and other traditional, sustainable, spiritual and religious practices and ways of life from around the world. Also, to preserve the ways of prayer with Holy Medicines / Sacramental Plants including but not limited to Holy Peyote, Ayahuasca, and Tobacco, some of our Holy Sacraments in which we pray and worship God in the way we see God through the Holy

Medicines for ourselves, our children, families and all the generations to come in accordance with religious freedom and all applicable laws worldwide without exception to race, color, sex, and or religion. As well as to promote a harmonious ways of life through activities that nourish, stimulate, and further the development of human sustainability, intelligence, and creativity through spiritual expression, cultural identity, cultural art, and historical consciousness, as well as to promote unification of all cultural religious and spiritual workers. Lastly it is our intent to educate humanity on our responsibility as members of this planet to live in a balanced harmonious way with all of creation.

ARTICLE IV MANNER OF ELECTION

Let it be known and constituted that the Founding members hereby known as the Founding Council also for Inti Runa People of the Sun Native American Church Corp. are appointed by incorporating agent under the authority and supervision of Inti Runa People of the Sun Native American Church Corp.

The Founding Council form the core governing council of Inti Runa People of the Sun Native American Church Corp., these members will always retain all rights and privileges within the corporation as the founding leaders of Inti Runa People of the Sun Native American Church Corp., and they can only be removed from position by their own accord. The Founding Council members constitute the main governing council and their actions and decisions surpass any decisions made by officers, advisors and or members when it comes to the highest benefit of the Corporation. Their term is indefinite and their positions are only replaced through the act of inheritance with the approval of the other founders.

OFFICERS

The Founding Council may appoint a Chairperson, one or more Vice Chairpersons, a secretary, a treasurer, and other such officers as the Founding Council believes will be in the best interest of the corporation (each an "officer", collectively known as "Officers"). As provided in the by-laws, any two or more offices may be held by the same person. The Officers shall have such duties as may be prescribed to them in the Bylaws and shall serve at the direction and pleasure of the Founding Council.

SPIRITUAL ADVISORS / MINISTERS (Road-Person) / CLERGYMEN (Medicine Person) / CUSTODIAN (Caretaker of Sacraments)

Inti-Runa People of the Sun Native American Church Corp will also have a directive position known as Spiritual Advisor. SPIRITUAL ADVISORS also to be known as MINISTERS (Road-Person) / CLERGYMEN (Medicine Person) / CUSTODIAN (Caretaker of Sacraments), are those who fulfill all requirements and prerequisites as laid out in the Bylaws and are also appointed by the Founding Council and have a good standing with all officers and members as understood within the Bylaws. Spiritual advisors can be members, Officers, and or Founding Council, but being any of the latter does not necessarily mean being a spiritual advisor. Being a Spiritual Advisor is a privilege and requires strenuous prerequisites and Founding Council approval. The Spiritual Advisors duties will be to oversee rituals and ceremonies with the upmost highest reverence, integrity, and diligence in accordance with tradition of how they received the altars and authority to conduct said ceremonies. Spiritual Advisors will not be part

of (unless they are Officers, members, and or Founding Council) administrative duties, governing, and or day-to-day maintenance of the Corporation. There will be classifications of types and duties of Spiritual advisors as written in the bylaws, but there will be one original Spiritual Advisor that leads all others and all others have to be approved of by the original Spiritual Advisor. The Bylaws will contain the components of what it means to be the original advisor and will lay the foundation and requirements for all others to become Spiritual advisors.
