

**ARTICLES OF INCORPORATION
OF
DUNEDIN COMMUNITY SAILING FOUNDATION, INC.**

In compliance with the requirements of FS Chapter 617 (Not for Profit), the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a non-profit business corporation.

ARTICLE I - NAME

The name of the Corporation is:

Dunedin Community Sailing Foundation, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This organization is a nonprofit corporation and is not organized for the private gain of any person. It is organized for charitable purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, which will provide facilities, equipment, education and funding to promote the sport of sailing and the development of sailors of all abilities, from beginners to Olympians.



ARTICLE VIII - DISSOLUTION


