RESTATEMENT

OF

ARTICLES OF INCORPORATION

OF

HEAVEN HELPING HANDS INC

The undersigned President of HEAVEN HELPING HANDS INC. executes these Restatement of Articles of Incorporation of HEAVEN HELPING HANDS INC, pursuant to Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **HEAVEN HELPING HANDS INC**, (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 3 - PROHIBITIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Second hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Restatement of Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal H1800170000 3

Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 4 - ADOPTION

These Restatement of Articles of Incorporation were adopted on 18 May 2018, and the number of votes cast by the Members for the Amendment of the Restated Articles of Incorporation was sufficient for approval.

ARTICLE 5 - PRINCIPAL OFFICE

The address of the principal office of this Corporation is 100 East Linton Boulevard, Unit 215B, Delray Beach, Florida 33483 and the mailing address is 1640 Stoneheaven Drive, Unit 1, Boynton Beach, Florida 33436.

ARTICLE 6 - OFFICERS

The Directors shall be elected by a majority vote of the Members of this Corporation. The officers of the Corporation shall be:

ARTICLE 7 - DIRECTORS

The Corporation will have three Directors whose mailing addresses shall be the same as the principal address of the corporation.

ARTICLE 8 - INCORPORATOR

The name and street address of the incorporator of this Corporation is Stallone Annulysee, whose address is 100 East Linton Boulevard, Unit 215B, Delray Beach, Florida 33483.

ARTICLE 9 - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE 10 - CAPITAL STOCK

This Corporation shall have no capital stock and shall be composed of members rather than shareholders.

ARTICLE 11 - QUALIFICATIONS OF MEMBERSHIP

The categories of membership, qualifications for membership and the manner of admission shall be as set forth in and regulated by the By Laws of the Corporation.

ARTICLE 12 - VOTING RIGHTS

Members of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.

ARTICLE 13 - LIABILITIES FOR DEBTS

Neither the members nor the members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.

ARTICLE 14 - REGISTERED OFFICE AND REGISTERED AGENT

The initial address of registered office of this Corporation is Stallone Annulysee, located at 1640 Stoneheaven Drive, Unit 1, Boynton Beach, Florida 33436. The name and address of the registered agent of this Corporation is Stallone Annulysee, 1640 Stoneheaven Drive, Unit 1, Boynton Beach, Florida 33436.

<u>ARTICLE 15 - EFFECTIVE DATE</u>

These Restatement of Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 16 - AMENDMENT

These Restatement of Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the Members, and approved at a Members meeting by a majority of the Members, unless all the Directors and all the Members sign a written statement manifesting their intention that a certain amendment of these Restatement of Articles of Incorporation be made.

ARTICLE 17 - DISSOLUTION

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
