**FIRST AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
CHRIST REFORMED COMMUNITY CHURCH, INC.**

In compliance with the requirements of Florida Statutes Chapter 617, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation.

**ARTICLE I  
NAME**

The name of the corporation shall be CHRIST REFORMED COMMUNITY CHURCH, INC. (the "Corporation").

**ARTICLE II  
PRINCIPAL OFFICE, REGISTERED OFFICE, AND AGENT**

The mailing address of the initial principal office of the Corporation is 14 East Bay Street, Jacksonville, Florida 32202. The street address of the initial registered office of the Corporation is 14 East Bay Street, Jacksonville, Florida 32202. AMENDMENT

The Corporation reserves the right to amend, alter, change, or repeal any provision contained in these Articles of Incorporation, in the manner now or hereafter prescribed by statute.

ARTICLE VIII  
DIRECTORS

The method of election of directors shall be set forth in the Bylaws of the Corporation.

ARTICLE IX

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as such Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX  
INDEMNIFICATION

The Corporation shall indemnify any incorporator, officer, or director, or any former incorporator, officer, or director, to the full extent permitted by law.
