ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I	NAME

The name of this Corporation shall be: SOUTHEAST SEARCH AND RESCUE CORPORATION

ARTICLE II PRINCIPLE OFFICE

Principle street address: 1432 ROSE HILL DR W. JACKSONVILLE, FL 32221

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to provide Search and Rescue operations with in a large area of the southeast United States, including but not limited to missing persons, disaster response, and Amber Alerts.

Said corporation is organized exclusively for non profit search and rescue purposes, educational, and charitable purposes, including, for such purposes, the making of distributions to organizations that Qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this corporation is irrevocably dedicated to search and rescue efforts and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

If this corporation is ever dissolved, the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE IV

MANNER OF ELECTION

The manner in which the directors are elected and appointed: Is through a vote at the annual meetings every year on the First Sunday of September. There is a nomination preceded directly by a vote made by current board members.
