ARTICLES OF INCORPORATION OF CHANGE FOR CHARITY, INC.

a Florida Not for Profit Corporation

WE, the undersigned, for the purpose of forming a corporation not for profit under Chapter 617 of the Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this Corporation is **CHANGE FOR CHARITY**, **INC.** (hereinafter called the "Corporation").

ARTICLE II PHYSICAL AND MAILING ADDRESS

The street address and mailing address of this Corporation is:

4001 Hollywood Bivd. Hollywood, FL 33021

ARTICLE III PURPOSES

This Corporation is hereby organized as a not for profit organization and is to be operated exclusively for charitable, educational and scientific purposes for the public benefit, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.

The Corporation is hereby organized as a not-for-profit organization and, as such, no part of the net earnings of the Corporation, if any, shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a Corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding Section of any future Internal Revenue Code, or (b) by a Corporation contributions to which are not deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding Section of any future Internal Revenue Code.

ARTICLE IV POWERS

The Corporation shall have the common law and statutory powers of a not for profit corporation which are not in conflict with the terms of the Articles of Incorporation and Bylaws of the Corporation. The Corporation shall also have all the powers necessary to implement the purposes of the Corporation.

In addition to all powers conferred on this Corporation by the State of Florida, the Corporation shall have all such powers incidental to accomplish its purposes and all the powers set forth in Chapters 607 and 617 of the Florida Statutes and the Bylaws of this Corporation, including, but not limited to, the following:

- 1. To accept, acquire, receive and hold by bequest, devise, grant, gift, purchase, exchange, lease, transfer or otherwise, any property, either real or personal, of whatever nature or description and wherever situated.
- To sell, exchange, convey, mortgage, lease, transfer or otherwise dispose
 of any such property, either real estate or personal, as the objects and purposes of the
 Corporation may require, subject to such limitations as may be prescribed by law.
- 3. To borrow money and, from time to time, make, accept, endorse, execute and issue bonds, debentures, promissory notes, bills of exchange and other obligations of the Corporation for money borrowed or in payment for the property acquired or for any of the other purposes of the Corporation, and to secure the payment of any such obligations by mortgage, pledge, deed, indenture, agreement or other instrument of trust, or by other lien upon, assignment of, or agreement in regard to all or any part of the property, rights, or privileges of the Corporation, wherever situated.
- 4. To invest or reinvest its funds in such stocks, bonds, debentures, mortgages or other securities and property as the Board of Directors shall deem advisable, subject to the limitations and conditions contained in any bequest, devise, grant or gift.
 - 5. In general, to exercise such other powers which now are or which

hereafter may be conferred by law upon a corporation organized for the purposes hereinabove set forth or necessary or incidental to the powers so conferred or conducive to the attainment of the purposes of the Corporation subject to such limitations as are or may be prescribed by law.

ARTICLE V NO MEMBERS

Pursuant to Section 617.0601, the Corporation shall not have any members, and all corporate powers shall be exercised by or under the authority of the Board of Directors.

ARTICLE VI BOARD OF DIRECTORS

1. Original Board of Directors. The Corporation shall have three (3) directors initially. The number of directors may be either increased or diminished, from time to time, pursuant to the Bylaws of the Corporation, but shall never be less than three (3). The names of the initial directors of this Corporation are as follows:

2. Management by Directors. The property, business and affairs of the Corporation shall be managed by the Board of Directors. The presence of a majority of the directors shall constitute quorum for the transaction of business. The Bylaws shall

provide for the meetings of Directors, including an annual meeting.

3. Election of Board of Directors. The method for the election or appointment of the Board of Directors of the Corporation shall be as provided in the Bylaws of the Corporation.

ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT

The Street address of the initial registered agent office shall be 4000 Hollywood Boulevard, Sulte 485-South, Hollywood, Florida 33021 and the initial registered agent located at such address is MITCHELL F. GREEN.

ARTICLE VIII BYLAWS

The power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors of the Corporation, in the manner provided in the Bylaws.

ARTICLE IX DISSOLUTION

In the event of the dissolution of the Corporation, the residual assets of the Corporation shall be turned over to one or more organizations which are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, as amended, or to the federal, state or local government for charitable, educational, or scientific purposes only.

ARTICLE X AMENDMENT

These Articles of Incorporation may be amended by the Board of Directors of the

Corporation at any regular meeting or at any special meeting called for that purpose; provided, however, that notice of the proposed amendment shall be given to each director at least five (5) days prior to the date of the meeting at which the Articles of Incorporation are to be altered, amended or repealed; provided, however, that no notice shall be required if all directors are present and all vote in favor of the amendment. The proposed amendment shall originate with the Board of Directors.

ARTICLE XI DEDICATION OF ASSETS TO PROPERTY

This Corporation is irrevocably dedicated to charitable activities and no part of the net income or assets of this Corporation shall ever inure to the benefit of any directors or officers thereof or to the benefit of any private individual.
