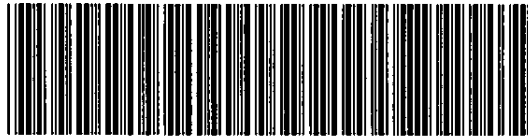

**Articles of Incorporation**  
**Of**  
**Proclaiming Life Ministries, Inc.**

The undersigned, acting as the incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

**Article 1**

The name of the corporation shall be Proclaiming Life Ministries, Inc.

**Article 2**

The principle street address and the mailing address of this corporation is 782 Hoyt Street, Chipley, Florida, 32428, Washington County

**Article 3**

This corporation is organized and operated exclusively for charitable and religious purposes within the meaning of 501(c)(3) of the Internal Revenue Code, including, but not limited to, the proclamation of the Gospel of Jesus Christ in the United States and in any foreign country; to establish and maintain a comprehensive system of charitable maternity homes for needy mothers; and any other lawful act or activity for which corporations may be organized under the Nonprofit Corporation Law of Florida, provided, however that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(c)(3) tax-exempt purposes, which are described in other provisions of these articles.

**Article 4**

The corporation shall not have members. All corporate powers shall be exercised by or under the authority of, and the affairs of the corporation managed under the direction of, the Board of Directors. The method of election of directors shall be stated in the Bylaws of the corporation. The corporation shall have a minimum of three (3) directors.

**Article 5**

The number of initial directors of this corporation is 4. Their names and addresses are as follows:

### **Article 6**

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

### **Article 7**

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

### **Article 8**

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

### **Article 9**

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
