Add Article VIII: Blue Turtle Green Bird Society Inc is organized exclusively for charitable, educational, and scientific pur-
poses, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under
section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Said corporation
shall operate as a not-for-profit organization and conform to the requirements set forth in the IRS Code Section 501(c)(3).
Add Article IX: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members
trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable
compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Articl
Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise
attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or
distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwith-
standing any other provision of these articles, the corporation shall not carry on any other activities not permitted to be
carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the
corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under
section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Add Article X: In the event of dissolution, the residual assets of Blue Turtle Green Bird Society Inc will be turned over to one or more organizations which themselves are exempt as organizations described in section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or local government for exclusive public purpose. No individual shall be entitled to share in the distribution of any Blue Turtle Green Bird Society Inc assets upon Dissolution, except individuals who are bona fide creditors.
