Purpose: Poli-Almanac Inc. is organized exclusively for charitable and community educational purposes, included in such purposes is the making of distributions to organizations that qualify as exempt organizations described under Section 501 (c ) (3 ) of the Internal Revenue Code, or corresponding section of any future federal tax code.
