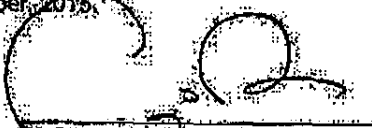
In compliance with the requirements of the laws of the State of Florida, and for the purpose of forming a corporation not-for-profit, the undersigned does hereby acknowledge:

1. Name of Corporation. The name of the corporation is PHMA PTO, Inc., a Florida corporation not-for-profit (the "Corporation").
2. Principal Office. The principal office of the Corporation is 2355 Nebraska Avenue, Palm Harbor, Florida 34683.
3. Registered Office - Registered Agent. The street address of the Registered Office of the Corporation is 2701 North Rocky Point Drive, Suite 900, Tampa, Florida 33607. The name of the Registered Agent of the Corporation is:

4. Purpose of the Corporation. The Corporation is organized to support the education of the students at Palm Harbor Montessori Academy by fostering the relationship among the school and the parents, enhancing educational opportunities through increased services, and providing additional educational tools to promote higher education.

7. Duration. Existence of the Corporation shall commence with the filing of these Articles with the Secretary of State, Tallahassee, Florida. The Corporation shall exist in perpetuity.
8. Amendments. These Articles of Incorporation may be amended in the manner provided in the Corporation's Bylaws.

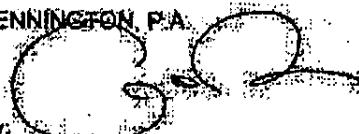
