ARTICLES OF INCORPORATION OF THE WOMEN OF ST. JAMES CATHOLIC CHURCH, INC. A Florida Corporation, Not For Profit

ARTICLE I <u>NAME</u>

The name of the corporation is THE WOMEN OF ST. JAMES CATHOLIC CHURCH, INC.

ARTICLE II DURATION

The term of existence of the corporation is perpetual.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is for charitable purposes. There shall be no power to engage in any activity which would disqualify the corporation as an exempt organization under §501 of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may be eafter be amended.

No part of the assets or the net earnings of this corporation shall inure to the benefit of any private shareholder or individual; no substantial part of the activities of this corporation shall be carrying on propaganda, or otherwise attempting, to influence legislation; and this corporation shall not participate or intervene in, any political campaign on behalf of any candidate for public office.
