Articles of Incorporation of Arts and Crafts For Christ, Inc.

The undersigned, acting as the incorporator of a corporation pursuant to Chapter 61% of the Florida Statutes, the Florida Not For Profit Corporation Act, adopts the following Articles of

Article 1

The name of the corporation is ARTS AND CRAFTS FOR CHRIST, INC.

Incorporation for such corporation:

Article 2

The principal place of business and mailing address of this corporation is 111 SHANNON DRIVE, LAKELAND, FLORIDA 33809.

Article 3

The corporation is organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law) including, but not limited to, for such purposes, teaching and sharing the Word of God with individuals and small groups using crafts as a teaching and disciple-making tool and engaging in any other activity not prohibited to corporations under the Florida Not-For-Profit Corporation Act that is in furtherance of Section 501(c)(3) purposes.

Article 4

The corporation shall not have members. The affairs of the corporation shall be conducted by the board of directors of the corporation. The method of election of directors shall be stated in the Bylaws of the corporation. The corporation shall have a minimum of three (3) directors. Article 5

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 3.

Article 6

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, distribute all of the remaining assets of the corporation to organizations organized and operated exclusively for religious, charitable, or educational purposes under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, for intervene in (including the publishing or distribution of statements) any political campaigneon behalf of or in opposition to any candidate for public office.

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

Article 10
