In accordance with Chapter 617.0202, Florida Statutes, the undersigned Incorporator hereby files these Articles of Incorporation to form a not for profit corporation under the laws of the State of Florida.

**ARTICLE I**

**Name**

The name of the corporation shall be: **MIAMI GENERAL EMPLOYEES UNITED, INC.**

**ARTICLE II

**ARTICLE III**

**Purpose**

Section 1. The purpose for which the corporation is organized is to contribute to the support of worthy candidates for State or Local office who believe, and have demonstrated their beliefs in, the principals to which the Miami General Employees, AFSCME Local 1907 of the American Federation of State, County, and Municipal Employees, AFL-CIO is dedicated. To further these purposes, the corporation is empowered to solicit, directly and indirectly, and accept voluntary personal contributions, and to make expenditures in connection with the attempt to influence the selection, nomination, or election of any individual to any State or Local office.

Section 2. The corporation, and its officers and subcommittees, shall possess and may exercise all powers and privileges set forth in these Articles or incidental thereto, together with the powers and privileges necessary or convenient to the conduct, promotion, or attainment of the purposes of the Committee or these Articles.
