Article III is amended and restated in its entirety as follows:

ARTICLE III: Purposes
The Corporation is organized and shall at all times be operated exclusively for religious, charitable, educational and
scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as it may be amended
from time to time (the "Code"), to be carried out in accordance with the mission and philosophy of the Franciscan Sisters,
Daughters of the Sacred Hearts of Jesus and Mary, St. Clara Province, of Wheaton, Illinois.
In connection with and in furtherance thereof, the Corporation shall have the following purposes:
(a) To be organized and operated exclusively for the benefit of, to perform the functions of, or to carry out the purposes
of Franciscan Minstries, Inc. and other affiliated nonprofit organizations, provided that such supported organizations are
exempt from Federal income taxation under Code Section 501(c)(3) and other than private foundations under Code Section
509(a).
(b) To acquire, own, operate and maintain the building located at 405 South 4th Street, Lake Wales, FL (the "Project"),
and activities incidental thereto. Without the prior written consent of the United States Department of Housing and Urban
Development ("HUD"), the Corporation shall not engage in any other business or activity, or hold any other asset, than the
Project.
(c) Subject to the foregoing, the Corporation is authorized to engage in any lawful activities within the purposes for
which a corporation may be organized under the Act, which are consistent with the foregoing purposes.
