# Amendments and Additions to Articles of Incorporation

#### Article III has been modified:

# Article III: Purpose of the Organization

The specific purpose for which this corporation is organized is exclusively for charitable, religious, educational and scientific purposes under section 501(c)3 of the Internal Revenue Code or corresponding section of any future federal tax code. This purpose includes the beautification and maintenance of public structures and works, prevention of deterioration within communities, unification of community residents, events that serve the public interest, and the training of individuals to increase their capacities.

#### Article 1X and Article X and have been added:

## Article IX: Prohibited Earnings Distribution and Organizational Activities

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or the corresponding section of any future federal tax code.

#### Article X: Dissolution

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
