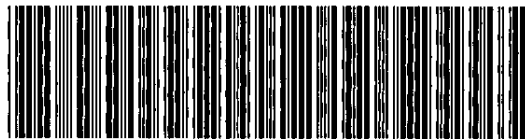

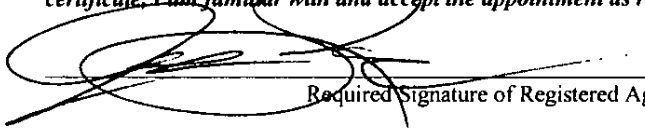

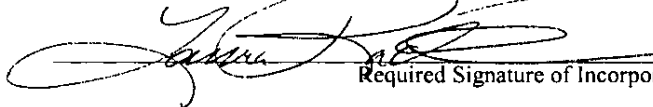

ARTICLE III PURPOSE

The purpose for which this corporation is organized shall be exclusively for religious, charitable, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, the Corporation is organized to:

- (a) Engage and unify the body of Christ in the Panhandle of Florida through fellowship and prayer, recognizing one church, many congregations,
- (b) Operate exclusively for charitable purposes which will qualify it as an exempt organization under 26 U.S.C.A. - (c) And shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication/distribution in any political campaign on behalf of any candidate for public office.
