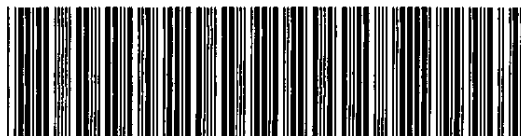

**ARTICLE 1
NAME**

The name of the corporation shall be: BLUE RIVER SCHOOLS FOR ARTS AND INNOVATON, INC.

**ARTICLE 2

**ARTICLE III
PURPOSE**

This Corporation is organized for the basic purpose to do all things reasonable and proper in the operation of nonprofit charter schools within the State of Florida, pursuant to the provisions of the Florida Statutes, Title XLVII – K-20 Education Code, Section 1002.33-Charter Schools. Said corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. It shall have those powers set forth in Section 1002.33-Charter Schools and all lawful powers necessary or convenient to carry out any such purpose, and all rights, privileges and authorities granted by or consistent with any applicable law, unless and only to the extent expressly restricted by these Articles or Bylaws.

The Corporation shall be a non-profit, non-stock corporation. No dividends or pecuniary profit shall be declared or paid to the member(s) thereof. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to make payments and distributions in furtherance of its lawful purposes. The Corporation may engage, without limitation as to duration or succession, in any lawful act or activity for which such non-profit corporation may be organized. The Corporation shall not carry on activities which are not permitted to be carried on by a corporation exempt from Federal Income Tax under the Internal Revenue Code, or the corresponding provisions of any future United States Internal Revenue Laws, as they may be applicable to Florida.

ARTICLE IV MANNER OF ELECTION

The authorized number and qualifications of members of the corporation, if any, the different classes of membership, the property, voting and other rights and privileges of members, and their liability for dues and assessment and the method of collection thereof, shall be set forth in the bylaws.

The Corporation shall have a Board of Trustees pursuant to the Charter granted to the Blue River Schools for Arts and Innovation, Inc., and shall be elected or selected in accordance with the provisions of the by-laws of the corporation. The Board of Trustees shall consist of not less than three (3) members and not more than nine (9) members.
