The undersigned, a majority of whom are citizens of the United States, desiring to form a Not-for-Profit Corporation under the Not-for-Profit Corporation Law of Florida, do hereby certificate TARY OF STATE TALLAMASSEE, FLORIDA

ARTICLE I NAME

Section 1.1 Name. The name of the corporation shall be DOWNTOWN DORAL CHARTER ELEMENTARY SCHOOL PTO, INC., a Florida not-for-profit corporation (the "Corporation").

ARTICLE II ORGANIZATION

- Section 2.1. Statement of Purposes. The purpose for which the corporation is organized shall be for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Not-For-Profit Corporation Act and to distribute the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- Section 2.2. Dissolution. In the event of the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE III OFFICE AND REGISTERED AGENT

- Section 3.1 Principal Office. The principal office of the Corporation shall be 8390 Northwest 53rd Street, Doral, Florida, 33166, and may be changed from time to time as the officers may choose.
- Section 3.2 Registered Agent. The Registered Agent of the Corporation shall be Cynthia M. Rodriguez at 25 Southeast Second Avenue, Suite 1100, Miami, Florida 33131.

ARTICLE IV MEMBERSHIP

Section 4.1. Members. The members of the Corporation shall be composed of any parent, guardian or other adult standing in *loco parentis* for a student, the principal, and any teacher employed at Downtown Doral Charter Elementary School, a not-for-profit Florida Corporation, located at 8390 Northwest 53rd Street, Doral, Florida 33166.

ARTICLE V BOARD OF TRUSTEE

Section 5.1. Board of Trustees. The Board of Trustees of the Corporation shall consist of four (4) members. The number of the Trustees may be either increased or diminished from time to time according to the Bylaws, but may never be less than three (3) members. Notwithstanding other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
