Articles of Incorporation (Amended)

Article I - Name

1.01 Name

The name of the corporation shall be The Space at 2106, Inc.

Articles II - Duration

2.01 Duration

The duration of the corporation is perpetual.

Article III - Corporate Addresses

Article IV - Purpose

4.01 Purpose

The Space at 2106, Inc. is a non-profit corporation and shall operate exclusively for arts, education and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. The Space at 2106, Inc.'s purpose is to be an art's cultural force; advocating for a diverse artistic voice in genre, medium and artist. Our focus is to probe published and developing works that explore cultural, social and intellectual identity; to educate the public through live performance, be it theatre, music, visual and/or performance art; to celebrate the advancement of social and cultural change and continue to create works that combat social injustice, inequalities and community deterioration through the use of art by fostering community conversation and action through public performances, workshops and community outreach events.

4.02 Public Benefit

The Space at 2106, Inc. is designated as a public benefit corporation

Article V - Non-Profit Nature

5.01 Non-Profit Nature

The Space at 2106, Inc. is organized exclusively for arts, charitable and educational purposes including, for such purposes, the making of distributions that qualify as exempt organizations under section501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code. No part of the net earnings of The Space at 2106, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for

services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

The Space at 2106, Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its arts, educational and charitable purposes. No part of the directors, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

5.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of The Space at 2106, Inc of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

5.03 Dissolution

In the event of dissolution, the physical venue location of The Space at 2106is the property of Robert Morris Holdings, LLC and is not a physical assets of The Space at 2106, as such, in the event of dissolution of the organization, management, operating decisions, expenses, debts, and any other responsibilities regarding the physical building will revert back to Robert Morris holdings, LLC. The residual assets of the corporation will be turned over to one more organizations which themselves are exempt as organizations described in sections 501(c)(3) or corresponding section of any future federal tax code, or to the Federal, State or local government for exclusive public purpose.

5.04 Prohibited Distributions

No part of the net earnings, properties of the directors of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV, Section 4.01.

5.05 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

5.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (1) by a corporation exempt from Federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.
