## A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I NAME**

The name of the corporation shall be: The Braylee & Brya K. Speed Foundation, Inc.

### **ARTICLE II PRINCIPAL OFFICE**
