Articles of Incorporation
In compliance with Chapter 617, F.S., (Not for Profit)

Article 1

Name: The name for the corporation shall be KIDBACKER FOUNDATION FOR ENTREPRENEURSHIP, INC.

Article VIII

Additional Provisions: The property of this Foundation is irrevocably dedicated to charitable or educational purposes. Upon the dissolution of the Foundation, its assets remaining after payment, or provision for payment, of all of the debts and liabilities of this Foundation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable or educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code. Upon the dissolution of the Foundation, none of the assets shall be distributed to any director or officer of the Foundation.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit or, or be distributed to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are tax deductible under Section 170(c)(2) of the Internal Revenue Code.
