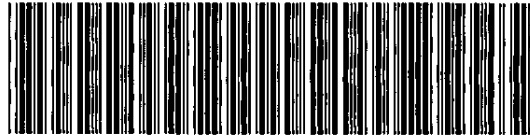

**ARTICLES OF INCORPORATION  
OF**

**FUNDACION FRANCIS TERAN & SONRISAS EN MOVIMIENTO, Inc.**

In compliance of Chapter 617 of the Florida Statutes, (Not for Profit)

**ARTICLE I - NAME**

The name of the Corporation shall be: **Fundacion Francis Teran & Sonrisas en Movimiento, Inc.**

**ARTICLE II - PRINCIPAL OFFICE**

The address of the principal office and the mailing address of the Corporation is 11380 NW 87th Ln, Medley, Florida 33178.

**ARTICLE III - DURATION**

This Corporation shall have a perpetual existence.

**ARTICLE IV - PURPOSE**

The purposes for which the Corporation is organized are:

1. To offer free assistance and support in areas such as oral prevention, operations, endodontics, periodontics, surgery, and orthodontics, and restoration, tooth decay, gum disease, oral cancer associated with pre-malignant lesions in the inner lining of the mouth and tongue.
2. Promoting healthy behavior both oral health and general health; through developing sports, physical activity and recreation as a permanent habit, to disadvantaged groups, providing social benefits of and improving their quality of life.
3. Organize and develop sporting events.
4. Build or improve sports' facilities.
5. Promote the development of training of: - Individuals in welding techniques for art sports equipment and training machines; - Athletes, coaches, athletes, practitioners, trainers, referees and judges, professional athletes.
6. Facilitate access to sports scholarships, and/or financial aid.

7. Generally to have and exercise all rights and powers conferred on nonprofit corporations under the laws of the State of Florida.
8. The purpose for which **Fundacion Francis Teran & Sonrisas en Movimiento, Inc.** is organized exclusively charitable and/or educational within the meaning of Section 501 ( c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

#### **ARTICLE V - DIRECTORS**

1. The manner in which the directors are appointed or elected is by majority vote of Directors, as set forth in the By-Laws of this Corporation.

#### **ARTICLE VI - RESTRICTIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph: "Notwithstanding any other provision of these articles, this corporation shall

not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

#### **ARTICLE VII - DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

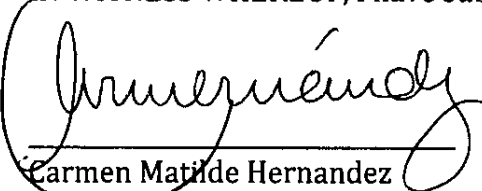
