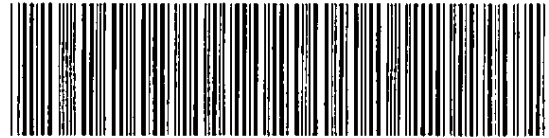

Article III is amended to read as follows: The specific purpose for which this corporation is organized is: to promote and enhance the quality of life within the Pleasant City community by fostering a sense of unity, advocating for the residents' interests, and undertaking initiatives that contribute to the community's overall well-being. Pleasant City First Neighborhood Association is organized exclusively for charitable, educational, and community-building purposes within the meaning of Section 501(c)3 of the Internal Revenue Code or the corresponding section of any future federal tax code.

Article IX will be added to the Articles to read as follows:

Dissolution: In the event of dissolution or winding up of the Pleasant City First Neighborhood Association (PCFNA), any assets remaining after the payment of all debts, liabilities, and expenses of the organization shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

The distribution of assets, in the event of dissolution, shall be determined by the Board of Directors of PCFNA at the time of dissolution. Such determination shall be made in accordance with applicable laws and regulations governing nonprofit organizations and shall be consistent with the organization's primary purpose as set forth in its Articles of Incorporation.

In no event shall any assets of the organization be distributed to any officer, director, or private individual. In the event that PCFNA has applied for and received recognition of tax-exempt status under Section 501(c)(3), the distribution of assets upon dissolution shall be made in a manner consistent with the requirements and limitations of that section.

If any of the specific purposes or provisions contained in this dissolution clause are determined to be invalid, illegal, or unenforceable under applicable laws or regulations, the remaining provisions shall remain in full force and effect.

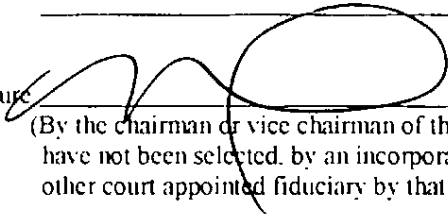
