

We, the undersigned, natural persons of age twenty-one or more, acting as incorporators of a corporation, adopt the following Articles of Incorporation for such corporation pursuant to the State of Florida Non-profit Corporation Act.

FIRST:

PURPOSE:

The purpose for which the Corporation is organized is:

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

FOURTH:

any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by (1) a corporation exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (2) by a corporation, contributions to which are deductible under Section 170 (c) of the Internal Revenue Code, or the corresponding section of any future federal tax Code.

B-DISSOLUTION

Upon the dissolution of the Corporation, the Board of Director's shall, after paying or making provision for payment of all the liabilities of the Corporation dispose of all the assets of the Corporation exclusively for the purposes of the organizations in such manner, or to such organization or organizations organized and operated exclusively for charitable purposes, as shall at the time qualify as an exempt organization or organizations under section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future tax code as the Board of Directors shall determine.
