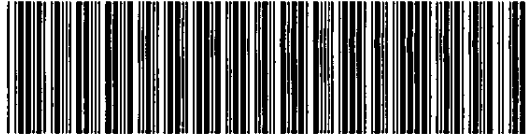

ARTICLES OF INCORPORATION  
VO TRU MEDITATION CENTER, INC.

We, the undersigned, natural persons of age twenty-one or more, acting as incorporators of a corporation, adopt the following Articles of Incorporation for such corporation pursuant to the State of Florida Non-profit Corporation Act.

FIRST: The name of the Corporation is: VO TRU MEDITATION CENTER, INC.,

SECOND: PRINCIPAL OFFICE  
Principal Street address: 3108 TURKEY CREEK RD.,  
PLANT CITY, FL 33566

THIRD: PURPOSE:  
The purpose for which the Corporation is organized is:

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 ( c ) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

FOURTH: The manner in which the directors of the Corporation are elected or appointed shall be provided in the BYLAWS OF THE CORPORATION. The Corporation shall have NO MEMBERS. ONLY PRESIDENT CAN APPOINT DIRECTORS ON BOARD TO REMAIN OR RESIGN OF THEIR POSITION OR FUNCTIONS.

FIFTH: The following provisions are hereby adopted for the purpose of defining, limiting and regulating the power of Corporation and it directors:

A- No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its incorporators, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of its purposes as set forth in these Articles. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not distribution of statements or otherwise)

any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by (1) a corporation exempt from *Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code* or the corresponding section of any future federal tax code, or (2) by a corporation, contributions to which are deductible under Section 170 (c) of the Internal Revenue Code, or the corresponding section of any future federal tax Code.

#### B- DISSOLUTION

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the Corporation dispose of all the assets of the Corporation exclusively for the purposes of the organizations in such manner, or to such organization or organizations organized and operated exclusively for charitable purposes, as shall at the time qualify as an exempt organization or organizations under section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future tax code as the Board of Directors shall determine.

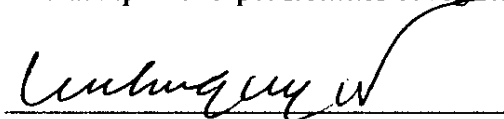
