FL Articles of Incorporation Attachment - AMENDMENT

Article III: PURPOSE

- Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- International Infant Victims of Wars Foundation, Inc. will be a targeted infant (birth to age one) help foundation that will work with international local family oriented nonprofits including, but not limited to, those working with family planning centers, single mothers groups, orphanages, and displaced child organizations. The Foundation will help these children in need with financial and material in-kind support.
- Our programs will focus on making a difference in each child's life by providing funds from our donors to aid in the ongoing development of these children who are under the guidance of approved nonprofit organizations working in these international countries. We will support special programs and services to support the needs of these children. Our goal is to provide extraordinary educational programs, development meaningful community relationships and promote the growth of each individual child in accordance with her physical, intellectual, and emotional needs.
- Our programs will also involve working with the Local Veterans Groups within the community to enlist the aid of these veterans in providing services to these children. Our efforts will be focused upon fundraisers and personal contacts to solicit monies that can help with supplies and activities which will improve the lives of these children. These veterans have a personal stake in becoming part of this program which will in turn help them as well in their road to recovery.

DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

CONFLICT OF INTEREST

No officer, Director, or member of the Corporation will have a direct or indirect financial interest in the Corporation's interest when it is contemplating entering into a transaction or arrangement that might result in a possible excess benefit transaction. This policy, which has been adopted by resolution of the governing board, is intended to supplement but not replace any applicable state and federal laws governing conflict of interest applicable to nonprofit and charitable organizations.

Article IV: THE MANNER IN WHICH DIRECTORS ARE ELECTED AND/OR APPOINTED:

Elections will be held at the annual meeting in **November**. Nomination for all positions may be made from the floor, but only with express consent of the person or persons nominated.

From a slate of nominees presented at the **October** meeting of the Corporation, the Board of Directors will elect from its membership the Executive Committee of the Board, comprised of the President, Vice President, Secretary, Treasurer and one (1) additional member at large. Each member of the Executive Committee will serve two consecutive two year terms and may be elected to successive terms without limit. Any vacancies occurring on this Committee may be filled by the Board of Directors.

The Executive Committee will have all the power and authority of the Board of Directors in the interim between regular Board meetings, and its acts, by majority vote of the entire membership of the Executive Committee will be binding upon the Corporation; provided, however the Executive Committee will exercise this authority only with respect of those matters deemed by the President or by a majority of the Executive Committee, to be of sufficient importance to require a decision and action prior to the next regularly scheduled meeting of the Board of Directors. The Executive Committee will recommend action by the Board of Directors with respect to any matter affecting the Corporation.

An affirmative vote of a majority of the Board of Directors present quorum and attending will be required to elect officers, board members, and to remove from office a trustee or officer for cause deemed sufficient by those voting for such removal.

Any member of the Board of Directors, who will have three (3) unexcused absences from regularly scheduled meetings of the Board in any fiscal year, will automatically be dropped as a member of the Board. Absences may be excused for just cause and may be registered verbally, in writing, by telephone or email prior to such meetings.

These methods of election and appointment are as stated in the bylaws of the International Infant Victims of War Foundation, Inc.
