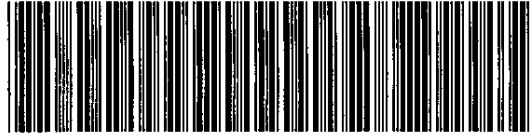

ARTICLES OF INCORPORATION  
CORBAN MINISTRIES INTERNATIONAL INC

ARTICLE I NAME

The name of this corporation shall be: CORBAN MINISTRIES  
INTERNATIONAL INC

ARTICLE II CORPORATE ADDRESS

The corporation's registered office is located at:  
4469 Bay Harbour Drive  
Jacksonville, Florida 32225

ARTICLE III PURPOSE

This corporation is organized exclusively for religious and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall be given to the glory of God through proclamation of His name, the ministry of intercession, and activities directed toward a great awakening in the nations. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a

corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE V DIRECTORS/OFFICERS

The corporation shall have no voting members. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No Director shall have any right, title, or interest in or to any property of the corporation. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. The corporation's first Board of Directors shall be comprised of the natural persons selected in accordance with the corporate by-laws. The initial CEO of this corporation shall be Lindy S. Diffenbaugh, 4469 Bay Harbour Drive, Jacksonville, Florida 32225.

#### ARTICLE VI REGISTERED AGENT

The Registered Agent of the Corporation is Guy L. Diffenbaugh, 4469 Bay Harbour Drive, Jacksonville, Florida 32225.

#### ARTICLE VII DEBT OBLIGATIONS AND PERSONAL LIABILITY

No Officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this corporation.

#### ARTICLE VIII DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall

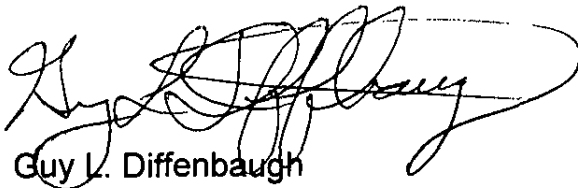
determine, which are organized and operated exclusively for such purposes.

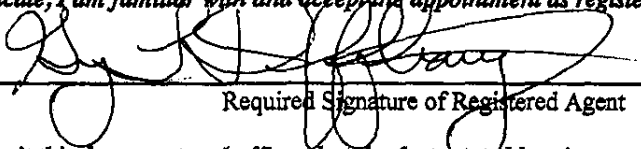
