Articles of Incorporation of INSPIRING TO EXCEL FOUNDATION INC.

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of <u>FLORIDA</u>, do hereby cartify:

First: The name of the Corporation shall be INSPIRING TO EXCEL FOUNDATION INC.

Second: The place in this state where the principal office of the Corporation is to be located is the City of <u>MIAMI, MIAMI-DADE</u> County. The principal office is to be located at:

Third: Sald corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 601(a)(3) of the Internal Revenue Code, Primarily the distributions will be of donated food to needy individuals or families in the community.

Fourth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propagands, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section \$01(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
