

AMEND: ARTICLE III – Corporate Purpose

The Corporation is organized exclusively for charitable and educational purposes under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. This principal objective is to be achieved through being a non-partisan and Non-Profit Corporation dedicated to provide education and training within the meaning of section 501(c)(3):

1. To encourage development and foster knowledge on civic, social, economic, financial, legal and political issues.
2. To cultivate, promote, support, advance and defend democratic values and processes; civil society; human rights (e.g., freedom of information, freedom of speech and expression, freedom of thought, freedom from discrimination and prejudice); gender equality; just governance; civilized and respectful political and social dialogue; peaceful resolutions to conflicts; and other such noble endeavors.
3. For the promotion of entrepreneurship and economic opportunities to help empower the poor, disadvantaged and underprivileged.

The character and essence of the Corporation is the same as its purpose.

ADD: ARTICLE IX – Prohibited Activities & Limitations

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ADD: ARTICLE X – Distribution of Assets Upon Dissolution

Upon the dissolution of the Corporation, after paying or making provisions for the payment of all the legal liabilities of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

ADD: ARTICLE XI – Indemnification

The Corporation indemnifies any directors, officers, employees, incorporators, and members of the Corporation from any liability regarding the Corporation and the affairs of the Corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the Corporation, or as otherwise provided under applicable statute.

ADD: ARTICLE XII – Existence

The Corporation shall have perpetual existence unless it is dissolved according to the laws of the State of Florida.


