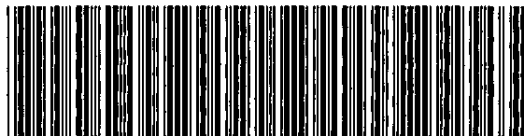

**ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, desiring to form a corporation not for profit, pursuant to the laws of the State of Florida, as contained in Chapter 617 of Florida Statutes, hereby certify as follows:

ARTICLE I - CORPORATE NAME:

The name of the Corporation shall be: **The Michelle Odeh Foundation, Inc.**

ARTICLE II - PRINCIPAL OFFICE:

The principle place of business and the mailing address of this corporation shall be:

ARTICLE III - PURPOSE:

The purpose for which the corporation is organized is:

The corporation is not organized for the private gain of any person. Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More specifically, The Michelle Odeh Foundation, Inc. is a nonprofit organization that contributes to a child/children wellbeing, through academic achievement and to help motivate their self-esteem as they journey through life. This will be accomplished by supporting their spiritual needs, providing charity to under-privileged children, and educational resources and outreach.

ARTICLE IV - DURATION

The duration of this corporation shall be perpetual, it shall have no stock and no members.

ARTICLE V - MANNER OF ELECTIONS

The directors shall be elected or appointed as established through the Bylaws of the corporation.

ARTICLE VI - LIMITATION OF CORPORATE POWERS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

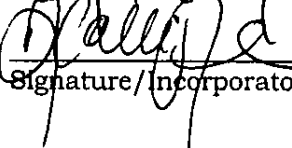
