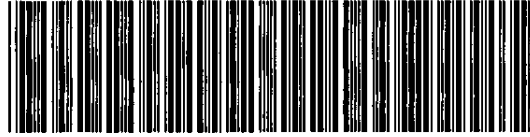

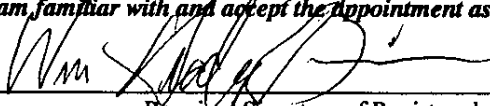

ARTICLE III PURPOSE:

Additional Statements of Purposes are stated herein to obtain tax exemption from the Internal Revenue Service under Section 501 (c) (3):

- a. This corporation is organized and operated exclusively for the purposes previously stated herein within the meaning of the Internal Revenue Code Section 501 (c) (3).
- b. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate or intervene in any political campaign (including publishing or distribution of statements) on behalf of any candidate for public office.
- c. The property of this corporation is irrevocably dedicated to the purposes of the corporation and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
- d. Upon dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational and/or religious purposes and which has established its tax exempt status under the Internal Revenue Code Section 501 (c) (3).
