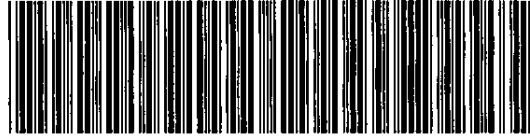



ARTICLE I

Name. The name of the corporation shall be ABBA BOYS' AND GIRLS' TOWN, INC.

ARTICLE II

Address of Principal Office. The address of the principal office of the corporation shall be:

3919 SW 29<sup>th</sup> Place  
Ocala, FL 34474

ARTICLE III

Purposes. The purposes of this corporation are as follows: (a) to operate exclusively in any other manner for such scientific, charitable and educational purposes as will qualify it as exempt organization under Section 501(c)(3) (or the applicable section of the IRC related to the purposes for which organized) of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws covering the distributions to organizations qualified as tax exempt; (b) for the advancement of scientific, charitable, educational, and any other related or corresponding charitable purposes by the distribution of its funds for such purposes, and; (c) for any and all other lawful purposes under Section 501(c)(3) (or the applicable section of the IRC related to the purposes for which organized) of the Internal Revenue Code, as amended including, but not limited to, the purposes of operating an orphanage provided these purposes do not conflict with the requirements of item (a), above.

ARTICLE IV

Election of Directors. The method of election of Directors shall be as stated in the Bylaws of the corporation.

ARTICLE V

Initial Registered Office and Agent. The corporation's initial registered office of this corporation at that address shall be: 3919 SW 29<sup>th</sup> Place, Ocala, FL 34474 and the name of the initial registered agent of this corporation at that address shall be: Charles D. Medina.

ARTICLE VI

Name and Address of Incorporator. The Incorporator's name is : Charles D. Medina and his address is 3919 SW 29<sup>th</sup> Place, Ocala, FL 34474.

ARTICLE VII

Distribution of Assets. Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively

for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for scientific, charitable and educational purposes as will qualify it as exempt organization under Section 501(c)(3) (or the applicable section of IRC related to the purposes for which organized) of the Internal Revenue Code, as amended (or the corresponding provision of any future United States Internal Revenue Law) or shall be distributed to the federal government, or to a state or local government, for a public purpose as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such Court shall determine, which are organized and operated exclusively for such purposes.


#### ARTICLE VIII

**Effective Date** The effective date of these Articles of Incorporation pursuant to F.S. § 617.0123(2) shall be the date of filing.

#### ARTICLE IX

**Tax Provisions.** The corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation will not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation will not make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation will not make any taxable expenditures as defined in section 4945 of the Internal Revenue Code, or the corresponding section of any future federal tax code.


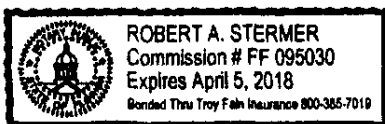
No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


