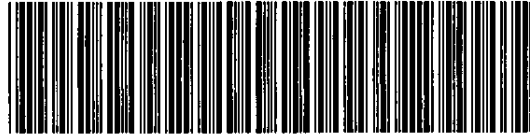

**ARTICLES OF INCORPORATION OF
FOR ASHER'S SAKE FOUNDATION, INC.**

We, whose names are affixed hereto do hereby associate ourselves together for the purposes of forming a corporation not for profit under the laws of the State of Florida and under the following Articles of Incorporation:

ARTICLE I

The name of the corporation is For Asher's Sake Foundation, Inc.

ARTICLE II

The purpose for which the corporation is organized is:

- 1) To provide information as well as seek outright gifts, gifts-in-kind and financial resources to assist children with Autism through financial support and public donations.
- 2) To work closely with various speech and language, occupational and behavioral therapy entities in Duval County for referral of patients who are unable to pay for these therapies and other important services.

ARTICLE III

All revenue, income and money received from the conduct of this corporation shall be used for the furtherance of the purposes of this corporation's purpose as described in Article II.

ARTICLE IV

The street address of the initial registered office is 2289 Walkers Glen Ln Jacksonville, Florida 32246 and the initial resident agent at that address is Tia Smith. The principal office and mailing address of the initial registered office is the same. The Board may from time to time move the principal office to any other address in Florida.

ARTICLE V

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be in the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in

(including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI

The corporation shall have three (3) directors initially. The number of directors may be increased or decreased from time to time by majority vote of the association officers, but shall never be less than (3). The procedure for election of directors is stated in the Bylaws. The names and addresses of the first members of the Board of Directors who, subject to the provisions of these Articles of Incorporation, the Bylaws of this corporation and the laws of the State of Florida, shall hold office until their resignation, removal from office, or death, is as follows:

Any two or more offices may be held by the same person.


ARTICLE IX

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

ARTICLE X

This corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter provided by law, and all rights conferred on shareholders herein are granted, subject to this reservation.
