ARTICLES OF INCORPORATION
OF
STAPLES VERO BEACH COMMERCIAL CONDOMINIUM ASSOCIATION, INC.

ARTICLE 1

The name of this corporation is Staples Vero Beach Commercial Condominium Association, Inc.

ARTICLE 2

- A. This corporation is a nonprofit corporation organized under the laws of the State of Florida. The purpose of this corporation is to engage in any lawful act or activity, other than credit union business, for which a corporation may be organized under such law.
