These Articles of Amendment to Articles of Incorporation of Bear Creek at Nocatee Homeowners Association, Inc., are made effective as of May 9, 2016 (the "Effective Date"), by **BEAR CREEK AT NOCATEE HOMEOWNERS ASSOCIATION, INC.**, a Florida not-for-profit corporation (the "Association") to change the Association's name from Bear Creek at Nocatee Homeowners Association, Inc. to **THE VISTA AT TWENTY MILE HOMEOWNERS ASSOCIATION, INC.**

RECITALS:

A. The Association desires to amend its Articles of Incorporation (the "Articles") as more particularly described hereafter and these Articles of Amendment have been proposed by the Association's Board of Directors and were approved on the Effective Date by the affirmative vote of Members holding not less than a majority of the total votes allocated to the Members of the Association.

NOW THEREFORE, the Association hereby amends the Articles as follows:

1. All references in the Articles to "Bear Creek at Nocatee Homeowners Association, Inc." are changed to "The Vista at Twenty Mile Homeowners Association, Inc."
2. All references in the Articles to "Bear Creek at Nocatee" are changed to "The Vista at Twenty Mile".
3. Except as specifically amended hereby, the Articles otherwise shall remain in full force and effect.
