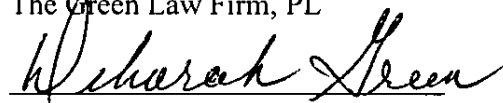

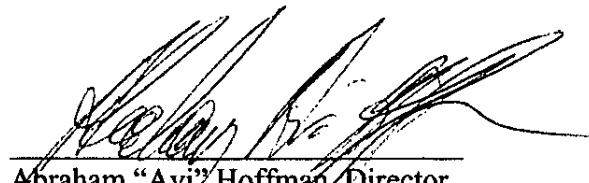

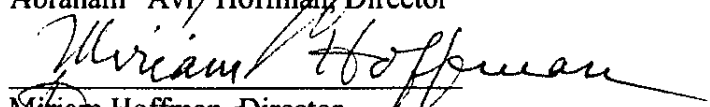
WHEREAS this Corporation is desirous of making such change; and

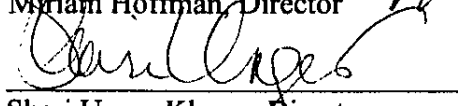
WHEREAS the undersigned, being the sole members of the Corporation's Board of Directors, do hereby consent to such name change; therefore be it
