ARTICLE III

The Friends of the New River Library is organized exclusively for charitable and community activity purposes including, for such purposes, the making of distributions to the library that qualified as a tax exempt organization described under Sections 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future code.

Upon dissolution of The Friends of the New River Library, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdictions in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized exclusively for such purposes.
