In compliance with Chapter 617.0202, F.S. (Not for Profit)

ARTICLE I: Name

The name of this corporation shall be Warriors on Water, Inc.

ARTICLE II: Principle Place of Business

The principal place of business is located at 655 Willowwood Ave., Altamonte Springs, FL 32714. The mailing address is PO Box 540132, Orlando, FL 32854.

ARTICLE III: Purpose

The purpose of the corporation is:

a. for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or such corresponding sections of any future federal tax; and

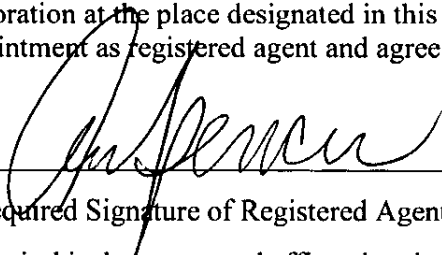
