

The purpose for which the corporation is organized is:

Kidology, Inc a non-profit charitable organization which serves in the Spirit of excellence with integrity and compassion for all children and teens in our community, our nation, and the whole world. Our ultimate purpose is to empower and provide opportunities for children to become all that GOD intends them to be; to change and save low income and disadvantaged at risk youth through developing the qualities needed to become responsible citizens and leaders.
