



Articles of Amendment To The Articles of Incorporation Of



DONLON DOCK OWNERS ASSOCIATION, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

Amendments adopted:

- 1) Strike Article III PURPOSES, Section A. 1., in its entirety, and in its place, add the following language:
 - 1. To be and constitute the Association to which reference is made in the Declaration of Covenants, Conditions, and Restrictions for the Donlon Dock Owners Association (hereinafter the "Declaration"), as amended from time to time, to perform all obligations and duties of the Association, and to exercise all rights and powers of the Association as specified therein, and as provided by law; and
- 2) Strike Article V POWERS, Section A., in its entirety, and in its place, add the following language:
 - A. The Association shall have all the common law and statutory powers of a corporation not-for-profit which are not in conflict with the terms of these Articles or the Declaration of the Association.
- 3) Strike Article V POWERS, Section C., in its entirety, and in its place, add the following language:
 - C. The Association shall have all of the powers necessary or desirable to perform the obligations and duties and to exercise the rights and powers set out in these Articles, or the Declaration, including, without limitation, the following:
 - 1. To levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the shared docks, as well as for any other purposes set forth in the Declaration;
 - 2. To manage, control, operate, maintain, repair, and improve property subjected to the Declaration or any other property for which the

Association by rule, regulation, Declaration, or contract has a right or duty to provide such services;

- 3. To enforce covenants, conditions, or restrictions affecting any property to the extent the Association may be authorized to do so under the Declaration of the Association;
- 4) Strike Article VI MANNER OF ELECTING DIRECTORS, in its entirety, and in its place, add the following language:

ARTICLE VI ELECTION OF DIRECTORS

The number of Directors constituting the initial Board of Directors is three (3). The number of Directors may be increased or decreased from time to time by a majority vote of the Members, but shall never be less than three (3). The name and address of each initial Director of the Corporation is as follows:

Directors of the Association shall be elected by a majority vote of the members at the annual meeting of the Association each year. The procedures for meetings of the Association shall be in accordance with the procedures set forth in these Articles of Incorporation.

- 5) Strike Article VIII MEMBERS, Section B., in its entirety, and in its place, add the following language:
 - B. The owner of each Lot subject to the Declaration shall be a member of the Association and shall be entitled to vote in accordance with the formula set forth in Article III of the Declaration, the terms of which are hereby incorporated by reference. Members may vote by proxy in accordance with Section 617.0721 of the Florida Statutes, as amended.

6) ' Add the following Article:

ARTICLE XIII ADOPTION OF CORPORATE BYLAWS

The Board of Directors may, at any meeting of the Association, adopt corporate Bylaws by a two-thirds (2/3) vote. Until such time as Bylaws are adopted and enacted by the Association, the Association shall be governed by the terms and provisions of the Declaration of Covenants, Conditions, and Restrictions for the Association, and by law. All meetings shall be conducted in accordance with the procedures set forth in these Articles of Incorporation.

7) Add the following Article:

Article XIV MEETINGS

Annual Meeting. A meeting of the members of the Association shall be held each year for the election of directors and for the transaction of any other business that may come before the meeting. The time and place of the meeting shall be designated by the board of directors.

<u>Place of Meeting</u>. The board of directors may designate any place within Volusia County Florida as the place of meeting for any annual meeting of the members. If no designation is made, the place of meeting shall be the principal office of the Association.

Notice of Meeting. Except as provided in F.S. Chapter 607, the Florida Business Association Act, written notice stating the place, day, and hour of the meeting and, in the case of a special meeting, the purpose or purposes for which the meeting is called, shall be delivered not less than 10 nor more than 60 days before the date of the meeting, to each member entitled to vote at the meeting. If mailed, the notice shall be effective when mailed, if mailed postage prepaid and correctly addressed to the member's address shown in the current record of members of the Association.

Waiver of Notice of Meeting. Attendance of a person at a meeting shall constitute a waiver of (a) lack of or defective notice of the meeting, unless the person objects at the beginning of the meeting to the holding of the meeting or the transacting of any business at the meeting, or (b) lack of defective notice of a particular matter at a meeting that is not within the purpose or purposes described in the meeting notice, unless the person objects to considering the matter when it is presented.

Members' List. The Association shall prepare an alphabetical list of the names of all its Members entitled to notice of the meeting with the address and.

contact information for each Member. The Members list shall be kept by the board of directors and shall be available for inspection by any Member upon demand, and shall be available for inspection at each meeting.
