Article 1. Name

The name of the corporation is All Faiths Internet Church, Inc.

Article 2. Purpose of Corporation

The Corporation is organized exclusively for charitable, religious and education purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 3. Prohibitions

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Second hereof.

No substantial part of the activities of the All Faiths Internet Church, Inc. shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on:

(A) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or

(B) by a corporation, contributions to which are deductible under section 1 70(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 4. Directors

All Faiths Internet Church, Inc. - The Directors shall be elected by a majority vote of the Members of this Corporation.

Article 5. Term of Existence

All Faiths Internet Church, Inc. - This corporation shall have perpetual existence.

Article 6. Capitol Stock

All Faiths Internet Church, Inc. - This corporation shall have no capital stock and shall be composed of members rather than stockholders.

Article 7. Qualification of Membership

All Faiths Internet Church, Inc. - The categories of membership, qualifications for membership and the manner of admission shall be as set forth in and regulated by the ByLaws of the Corporation.

Article 14. Amendment:

These Articles of Incorporation may be amended in the manner provided by and Every amendment shall be approved by the Board of Directors, proposed by them to the voting members, and approved at a members meeting by a majority of the Members, unless all the Directors and all the Members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

*******Article 15. Indemnification

If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected. All references in these Articles of Incorporation to "director", "officer" "employee", and "agent" shall include the heirs, estates, administrators, executors, and personal representatives of such persons.

Article 16. Covenant Not to Sue

All Faiths Internet Church, Inc. - The Corporation agrees that it will never institute any action or suit at law or in equity against any director or officer of the Corporation, nor institute, prosecute, or in any way aid in the institution or prosecution of any claim, demand, action, or cause of action for damages, costs, loss of services, expenses, or compensation for or on account of any damage, loss or injury to person or property, or both, whether developed or undeveloped, resulting or to result, known or unknown, past, present, or future, arising out of a director or officer of the Corporation's service to the Corporation.

Article 17. Dissolution

All Faiths Internet Church, Inc. - Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal officer of the corporation is then located, exclusively for such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
