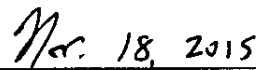
ARTICLE X DISSOLUTION

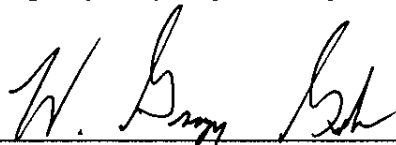
