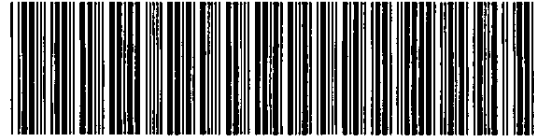

**FIRST AMENDMENT**  
to  
**ARTICLES OF INCORPORATION**  
of  
HACIENDA DE YBOR INC  
(a Non-for-Profit Florida Corporation)

THIS FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION was unanimously agreed upon by all voting members and effective as of the 23<sup>rd</sup> day of October, 2017.

**RECITALS**

WHEREAS pursuant to the Articles of Organization of Haciendas de Ybor, Inc. a Non-for-Profit corporation, was formed on November 20, 2015 in accordance with and pursuant to Florida Law (the "ACT").

NOW, THEREFORE, article III is amended to include the following:

**Section 1. Permitted business.** The company is organized for the permanent purpose of provision of suitable and affordable housing to the elderly and those of low income levels. Rates fall below customary charges of individuals with greater financial means or those of comparable apartments within the surrounding area.

**Section 2. Services.** Programs shall take place with regularity with purpose of improving social welfare within the community. Its main aim will be the establishment of an environment conducive of dignity, improvement of social interaction, health and relief of distress from financial obligations. These programs will be organized by the resident manager.


**Section 3 Safety.** The property shall provide a safe environment with purpose of creating an atmosphere with less societal stress. Such provision can be satisfied by the implementation but not limitation of surveillance systems, gating, and/or fire/medical alert responsiveness.

**Section 4. Dissolution.** The company can be dissolved by the shareholders in setting of insolvency. Otherwise, upon dissolution, such assets would be distributed to exempt purposes as stated in code 501 (C) 3.
