TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.006, Florida Statutes, this Florida Not for Profit corporation hereby adopts the following amendments to its Articles of Incorporation:

- Section 10.1 of Article 10 of the Articles of Incorporation entitled "Number and Qualification" is hereby amended and replaced in its entirety (with added language underlined and bold and deleted language struck through):

Section 10.1 Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of three (3) directors, unless the size of the Board is changed in the manner provided by the By-Laws. Directors need not be members of the Association, other than those representing the Developer, must be Unit Owners, or if a Unit is owned by an entity. Directors, other than those representing the Developer, must own an equitable or beneficial interest in the Unit Owner.

- Pursuant to Section 13.4 of the Articles of Incorporation, the foregoing amendment was made by the Developer pursuant to the authority given to it in the Condominium Declaration. Neither Board nor Member approval was required.
