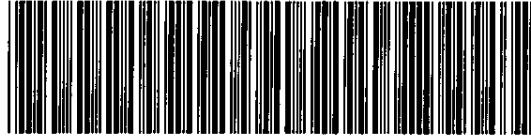

Articles of Incorporation

In compliance with Chapter 617, F.S. (Not for Profit)

The undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

ARTICLE I NAME

The name of the corporation shall be: **Karma Yoga Outreach, Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal office (and mailing address) of this Corporation shall be:
2888 B Ringling Blvd., Sarasota, FL 34237

ARTICLE III PURPOSE

The purpose for which this non-profit 501(c)(3) corporation is organized is to reach out and serve the broader community by providing specialized therapeutic yoga to targeted populations in need, including without limitation, veterans, children with special needs, persons with debilitating diseases and persons recovering from addictions, and to raise awareness and educate the community about the healing and therapeutic benefits of yoga in the treatment of physical, mental and psychological trauma, disease and disorder.

Section 1. Limitations

This corporation is organized and operated exclusively for the charitable and educational purposes within the meaning and pursuant to Chapter 617 of the Florida Statutes and Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law as applicable to an organization exempt from federal income tax.

Section 2. Property

The property, assets, profits and net income are dedicated irrevocably to the purposes set forth in Article III. No part of the profits or net earnings of the corporation shall inure to the benefit of, or be distributable to directors,

trustees, officers, members (if any) or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

Section 3. Political Activity

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign or behalf of or in opposition to any candidate for public office.

Section 4. Other Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not knowingly carry on any other activities prohibited under Chapter 617 of the Florida Statutes and Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future United States Internal Revenue law as applicable to an organization exempt from federal income tax.

Section 5. Dissolution

Upon the winding up and dissolution of the corporation, after paying or adequately providing for the payment of debts, obligations and liabilities of the corporation, the remaining assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future federal tax law. Such organization shall be selected by a majority vote of the Board of Directors.

ARTICLE IV MANNER OF SELECTION

Each Director shall be appointed by a majority vote of the Board of Directors at a meeting where a quorum is present. The Board of Directors may elect to replace a Director, re-appoint a Director, fill a vacancy, or

expand the Board of Directors by a majority vote of the Board of Directors at a meeting where a quorum is present (or by the sole remaining Director(s)).

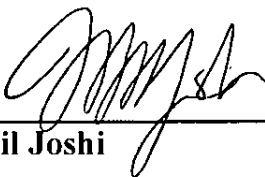

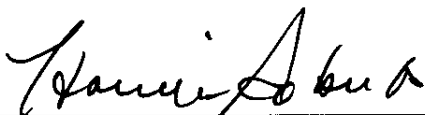
