ARTICLES OF INCORPORATION FOR LIGHTHOUSE BAY CHARITABLE FOUNDATION, INC.

The undersigned, hereby files with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation not-for-profit in accordance with the provisions of Chapter 617, Florida Statutes, for the sole purpose of organizing a non-profit corporation and to that end sets forth the following:

ARTICLE I NAME

1.1 The name of the corporation, herein called the "Corporation", shall be the LIGHTHOUSE BAY CHARITABLE FOUNDATION, INC. (the "Corporation")

ARTICLE II PLACE

2.1 The corporate office address is at:

23740 Olde Lighthouse Road Bonita Springs, Florida 34135.

ARTICLE III PURPOSE

- 3.1 The Corporation shall be organized for the exclusive purpose of acting as a non-profit, tax exempt organization under Sections 501(c)(3) of the U.S. Internal Revenue Code of 1986, as amended (the "Code"), and shall be operated exclusively for the following exempt purposes:
 - A to sponsor, promote and undertake exclusively charitable activities as an exempt organization under Section 501(c)(3) of the Code that will focus on supporting good health, medical care, education, and the general welfare of the residents of local communities, with a particular emphasis on the needs of children:
 - B to solicit, receive and administer funds and gifts made for charitable and community purposes without limitations as to amounts or value, except as such limitations may be imposed by law;
 - C to exclusively make gifts or grants to organizations qualified as charitable organizations under Section 501(c)(3) of the Internal Revenue Code and that are organized to further the goals of the Corporation.

ARTICLE IV MEMBERS

4.1 The corporation shall be organized on a non-stock basis and shall have no members.

Article V DIRECTORS

- Board of Directors, the precise number of which shall be set by the Bylaws of the Corporation, provided that there shall be a minimum of three directors at all times. Each member of the Board of Directors shall be elected in the manner and for the terms prescribed in the Bylaws, and shall hold office until their respective successors are duly elected and qualified. The affairs of the Corporation shall be managed by this official board, which shall elect officers as follows: President, Vice-President, Secretary and Treasurer, which officers shall be provided for in the Bylaws. Each officer shall be elected from time to time in accordance with the Bylaws and each officer shall hold office until his or her successor is elected and qualified.

ARTICLE VI LIMITATIONS

- 6.1 No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.
- 6.2 No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or

distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

6.3 Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

ARTICLE VII TERM

7.1 The term of the Corporation shall be perpetual or until dissolved by due process of law.

ARTICLE VIII DISSOLUTION

8.1 In the event of dissolution of the Corporation, the residual assets of the Corporation will be distributed to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3), 509(a)(1) or (2), and 170(c)(2) of the Code, or corresponding sections of the Internal Revenue Code, for exclusive public use.
