ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I

The name of the Corporation shall be:

ARTICLE II

The principle place of business and mailing of this corporation shall be:

ARTICLE III

The corporation is organized pursuant to the provision of the State of Florida Nonprofit Corporation Act. The corporation is public benefit corporation and a religious corporation. The corporation has a perpetual duration

ARTICLE IV

The purpose for which the corporation is organized and operated are exclusively religious, charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United State internal revenue law. The corporation's religious, charitable and educational goals shall be met by its commitment to serve as a faith-based ministry. Such commitment shall be fulfilled by doing whatever is legal under Florida law as pertaining to Not-for-Profit corporations.

ARTICLE V

Section 1: The Corporation shall have no members, and shall be governed exclusively by its Board of Directors. The manner in which the directors of the corporation shall be elected or appointed shall be governed by the provision of the corporation.

Section 2: The powers and business affairs of the corporation shall be exercised and managed by or under the authority or direction of the corporation's Board of Directors. The number of directors may be increased or decreased from time to time by a majority of the directors, but as no time shall there be fewer than three (3) directors of the corporation.

Article X
ACTION BY WRITTEN CONSENT

Action may be taken by use of signed written consent by the number of director or committee members whose votes would be necessary to take action at a meeting at which all person entitled to vote were present and voted. Each written consent must bear the date of signature of each person signing it. Consent signed by less than all of the directors or committee members is not effective to take the intended action unless consents, signed by the required number of persons, are delivered to the nonprofit corporation within sixty (60) days after the date of the earliest dated consent delivered to the nonprofit corporation. Delivery must be made by hand, or by certified or registered mail return receipt requested. The delivery may be made to the registered office, registered agent, principal place of business, transfer agent registrar, exchange agent or an officer or agent having custody of books in which the relevant proceeding are recorded. If the delivery is made to the President or principal executive officer of the corporation.

The corporation will give prompt notice of action taken to person who does not sign consents. If the action taken requires documents to be filed with the Secretary of State, the filed documents will indicate that the written consent procedures have been properly followed.

The telegram, telex, cablegram or similar transmission by a director or committee member, or photographic, facsimile or similar reproduction of the signed writing is to be regarded as being signed by the director or committee member.

Article XI
POLICY OF NONDISCRIMINATION

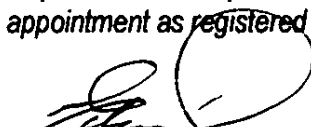
No person on the ground of race, color, sex or national and ethnic origin shall be excluded from any activity established by the corporation or by the corporation in connection with its various ministries or activities, nor shall any person on such grounds be excluded from participation in, or be denied the benefit of, or otherwise subjected to discrimination under, any program or activity of the corporation, and as long as each person is in compliance with the bylaws of the CICM.

Article XII
IN EVENT OF DISSOLUTION

In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objects and purposes herein set forth, all of the business, property and assets of the corporation shall go and be distributed to a nonprofit corporation qualifying as an organization exempt under the provision of Section 501(c)(3) of the internal Revenue code of 1986, as amended, or any superseding statutes thereof, as an organization qualifying as a public charity under the provision of Section 509(a)(1) or 509(a)(2) of the internal Revenue Code of 1986, as amended, or any superseding statute thereof as the directors of the corporation may select and designated; and in no event shall any of the said assets or property, in the event of dissolution thereof, go or be distributed or contributed by such directors, for any other such purpose.

Any such assets not so disposed of shall be disposed of by the district court of the county in which the principal office of the corporation is the located exclusively for such purposes, or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept services of process for the above stated corporation at the place designated in this certificate. I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
